Importation of milling wheat grain from Ukraine -60,000 MTS +/- 10% - (Tolerance)

Reference to the request made by you on 04th December 2020 regarding above, there is no objection in importing milling wheat from Ukraine while strictly adhering to the following conditions.

1. Should make necessary arrangement to transfer, store and process wheat grain within the sea port without exposure to the environment to minimize the risk to the Agriculture.
2. Imported Wheat grains are not permitted to sell in the local market
3. Should produce a phytosanitary certificate stating that the consignment is free from following pest as per the phytosanitary standards of Sri Lanka.
Trogoderma granarium (khapra beetle)
4. The consignment has been fumigated appropriately at the exporting country (pre shipment fumigation) with recommended dosage of either Methyl Bromide or Phosphine to eliminate any stored pests. Treatment details must be endorsed on the Phytosanitary Certificate.

This permission letter is valid only for one year from 07.01.2021
