The State Service of Ukraine on Food Safety and Consumer Protection (hereinafter - SSUFSCP) affirms its assurances of highest respect to the Directorate General on Health and Food Safety of the European Commission and for the implementation of Regulation (EU) 2020/1292 of 15 September 2020 as regards measures to prevent the entry into the Union of *Agrilus planipennis* Fairmaire (hereinafter – A. planipennis) from Ukraine and amending Annex XI to Implementing Regulation (EU) 2019/2072.

According to the results of inspections conducted by the SSUFSCP in 2018-2020 with the help of pheromone traps, a quarantine regime was introduced due to the detection of A. planipennis on an area of 536.8 hectares in some territories of Luhansk region which are defined in Annex 1 to this letter.

In addition, in accordance with the Annex 2, we provide information on the 100 km area which borders with quarantine zones of Luhansk region.

At the same time, we inform that Ukraine is a pest free area in accordance with the International Standard for Phytosanitary Measures № 4 and EU Regulation, based on the results of inspections of Ukraine by SSUFSCP and on the basis of scientific data.

The list of regions of Ukraine and districts of Donetsk, Luhansk and Kharkiv regions, which are considered as a pest free area, is provided in Annex 3 of this letter.

In order to prevent unjustified barriers in international trade while issuing of phytosanitary certificates for plants and plant products of plants of the genus *Fraxinus* L., *Juglans ailantifolia* Carr., *Juglans mandshurica* Maxim., *Ulmus davidiana* Planch. and *Pterocarya rhoifolia* Siebold & Zucc., State phytosanitary

inspectors will indicate the region of origin of the consignment in column 5 ("Place of origin") of the PC. In the case consignment is originating from Donetsk, Luhansk and Kharkiv regions - the region as well as district of origin shall be indicated. In this case, column 11 of the phytosanitary certificate will indicate the information "the consignment meets the requirements of Commission Implementing Regulation 2020/2072, Annex XI and Regulation 2020/1292, Annex point (a)".

It should be noted that in 2021 the SSUFSCP together with the State Forest Resources Agency of Ukraine will conduct surveys of the territory of Ukraine, including the use of pheromone traps.

We will inform you additionally on the results of examinations or detection cases of new outbreaks of *A. planipennis*.

In addition, in order to freely export Ukrainian timber of the genus *Fraxinus* L., *Juglans ailantifolia* Carr., *Juglans mandshurica* Maxim., *Ulmus davidiana* Planch. and *Pterocarya rhoifolia* Siebold & Zucc., we kindly ask you to immediately inform EU member states about the establishment of a free area in Ukraine from *A. planipennis*.


Taking this opportunity, we once again express our respect and hope for further fruitful cooperation.
