Directorate-General for Health and Food Safety (DG SANTE)

The State Service of Ukraine on Food Safety and Consumer Protection (hereinafter – SSUFSCP) presents the assurance of high respect to the Directorate-General for Health and Food Safety of the European Commission and inform following.

In connection with the detection in 2023 of a new focus emerald ash borer (*Agrilus planipennis* Fairmaire) on the territory of Ukraine, the SSUFSCP sent information regarding the territories of where the quarantine regime was introduced due to the detection of *Agrilus planipennis* Fairmaire by the SSUFSCP letter dated of 15.11.2023 No. 13.1.1-9/24091.

Information was also provided on the 100-kilometre zone, bordering the quarantine zones of the territories where the quarantine regime was introduced and areas that are free from this pest.

Herewith, in connection with the administrative-territorial reform in Ukraine, according to the Resolution of the Verkhovna Rada of Ukraine No. 807-IX «On the Formation and Liquidation of Districts» dated of 17.07.2020 which provides for the merger of existing districts, the creation of territorial communities within these districts, the SSUFSCP provides updated and relevant information:

in Annex 1 regarding the territories of Ukraine where the quarantine regime was introduced due to the detection of *Agrilus planipennis* Fairmaire;



in Annex 2 regarding the 100-kilometre zone bordering the quarantine zones of Luhansk and Kharkiv regions and Kyiv city, indicating the districts and territorial communities;

in Annex 3 regarding the territories of Ukraine designated as *Agrilus planipennis* Fairmaire free zone, including districts and territorial communities.

Taking into account the mentioned above, we kindly ask the Directorate-General for Health and Food Safety of the European Commission to consider the information provided in this letter in order to allow the export of timber from areas designated as free from *Agrilus planipennis* Fairmaire.

Taking this opportunity, the SSUFSCP reiterates its assurances of highest respect to the Directorate General for Health and Food Safety of the European Commission and looks forward to further fruitful cooperation.
