**To trade partners**

*On approval of forms of the international  
certificates for import to Ukraine*

Following the WTO notification No. G/SPS/N/UKR/138/Add.2, the State Service of Ukraine on Food Safety and Consumer Protection (SSUFSCP) informs all trade partners that generic forms of the international certificates for introduction into the customs territory of Ukraine of products of animal origin, feed, hay, straw, animal by-products and derived products thereof have been approved by the Order No. 1329 dated of 14.07.2020 by Ministry of Economic Development, Trade and Agriculture of Ukraine, registered in the Ministry of Justice of Ukraine on 22 July 2020 under No. 687/34970. The Order will come into force on 24.08.2020.

Please note that import into the customs territory of Ukraine of products mentioned above accompanied by international (veterinary) certificates issued prior to 24.08.2020 is possible.

Further import starting from 24.08.2020 into the territory of Ukraine of products of animal origin, feed, hay, straw, animal by-products and derived products thereof provided that consignments are accompanied by the forms of international certificates that are published on the official website of Verkhovna Rada of Ukraine by the link:

At the same time, bilaterally veterinary certificates that have been previously agreed between the competent authorities of the exporting countries and Ukraine remain valid. Those are published at the official SSUFSCP website ([www.dpss.gov.ua](http://www.dpss.gov.ua)) in the section “International Cooperation” – “Certificates for import to Ukraine”.

Therewith, we inform that the generic form of veterinary (sanitary) certificate covering fish and fishery products for export to Ukraine that is available by the link: <https://dpss.gov.ua/storage/app/sites/12/uploaded-files/Mizhnarodne%20spivrobotnictvo/vs-riba-riboprodukti.pdf> will be officially cancelled from 24.08.2020 (as far as generic/approved form will officially come into force).

Additionally, products of animal origin, feed, hay, straw, animal by-products and derived products thereof shall be imported to the customs territory of Ukraine provided that they come from an establishment listed in the register of countries and establishments authorised for the importation (sending) of products to the customs territory of Ukraine in accordance with the requirements of legislation on state control.

Acting register (list) of abovementioned establishments is published at the official SSUFSCP website ([www.dpss.gov.ua](http://www.dpss.gov.ua)) in the section “Registers”.

Moreover, import of products to the customs territory of Ukraine is allowed from establishments included to the relevant registers, approved by the European Commission according to the Order of the Ministry of Agrarian Policy and Food of 01.04.2014 No. 118 «On recognition of equivalence of the system of control over production and circulation of products and raw materials of animal origin of the European Union».
